Dear Mom and Dad:

We thank you for your interest in OPS Summer Camp for your child! We believe that summer months should be about children having tons of fun, while continuing to learn. We feel that all of our children will enjoy and benefit from our activities this summer!

The all inclusive fees for your child's summer care and activities will be as follows: Weekly fee will be \$127 with a prepaid activity fee of \$200.00. The activity fee will be due at time of registration.

All expenses for your child's activities have been included in your activity fee and your tuition. No extra money will be needed, however, if your son or daughter would like to purchase extra snacks or items from a gift shop on outings, you may wish to send a small amount of money.

Bamberg Recreation Club does have a small canteen where chips, ice cream, popsicles, etc. are sold. We do provide snacks at the pool, however, children LOVE to wait in line to purchase from the canteen! If your child would like to purchase a snack, you may want to send a small amount of money. Usually \$2.00 is plenty.

A T-Shirt will be provided for each child enrolled in summer camp. We would like for your child to wear this shirt on Field Trip Days.

If your child will be arriving late, please check your calendar carefully for departure times for all trips, or call the office to verify those times. We would hate to leave anyone behind, but will not be able to delay the bus to wait for a child.

Please note that the week of July 13th, we have altered our normal schedule for swimming and the Barrier Island Tour.

RISKS MAY INCLUDE, BUT ARE NOT LIMITED TO, SLIPPING AND FALLING, LANDING IMPROPERLY, COLLISIONS WITH FIXED OBJECTS, MOVING OBJECTS AND/OR OTHER PEOPLE WHICH MAY RESULT IN SPRAINS, FRACTURES, BREAKS, SCRAPES, BRUISES, DISLOCATIONS AND INJURIES TO HEAD, BACK AND NECK.

In consideration of the services provided by GAMECOCK GAMERS, LLC, an SOUTH CAROLINA limited liability company, who is the owner and operator of ADRENALINE ENTERTAINMENT CENTER(the "Facility") and my desire to spectate and/or participate in the activities and services provided by GAMECOCK GAMERS, LLC at the Facility today and in the future (GAMECOCK GAMERS, LLC and its individual members, managers, directors, officers, agents, employees, volunteers, representatives, servants, predecessors, successors, assigns, affiliated entities, heirs, personal representatives and all other persons, firms, or entities claiming by or through them are hereinafter known as "Facility Owner");

(a) agree to use the FACILITY in a safe and responsible manner;
